CEDAR FALLS- Wendell H. "Chris" Christensen, 80, of Cedar Falls, died Tuesday, March 23, 2010 at Sartori Memorial Hospital.

He was born October 1, 1929 in Nashua, the son of Wendell H. and Laretta H. (Forbes) Christensen. He married Pauline Watters on July 20, 1953 in Cedar Falls.

Mr. Christensen served in the US Army during the Korean Conflict and served as Black Hawk County Sheriff from 1974 to 1988.

Survivors include his wife, Pauline; two daughters, Karen (Paul) Hanson of Hudson, and Wendy (Dave) Smith of Cedar Falls; a son, Wendell H. III (Lianne Fernandez) of S. Daytona, FL; six grandchildren; and four great-grandchildren.

Preceded in death by two brothers, Ronald and Welden; and a sister, Waneta.

Family will receive friends from 3 to 7 p.m. Friday at the Richardson Funeral Home, Cedar Falls.
